

MAINTENANCE AND SWIMMING POOL WORKER II - SPECIALIZED

DEFINITION

Under general supervision, perform a variety of semiskilled and skilled maintenance duties at district swimming pools, surrounding areas and related equipment, and other district property; operate, clean, and maintain district swimming pools and all related equipment; assist other maintenance personnel with related duties as assigned; perform other related work as required.

ESSENTIAL FUNCTIONS

Perform a variety of technical duties and activities related to the cleaning, maintenance, and repair of district swimming pools, facility maintenance, and basic plumbing; prioritize, organize, schedule, and coordinate activities related to the preventative maintenance and repair of swimming pool equipment; perform routine swimming pool maintenance tasks, including vacuuming pools, cleaning pool restrooms, emptying pool area trash, cleaning pool decks, testing pool water, troubleshooting and adjusting electronic pool controllers, backwashing pool filters, maintaining chemical feed systems, maintaining circulation pumps, and brushing and cleaning swimming pool surfaces; store and maintain adequate inventory of swimming pool supplies; keep accurate daily records of water chemistry, flow rates, pool temperatures, and required safety signage and equipment in accordance to county public health code requirements; operate district service vehicles, heavy equipment, and other related motorized equipment; assist in or perform a variety of functions in the construction and maintenance of plumbing systems (water, gas, air, chemical, hydraulic), sewers, plumbing fixtures, water heaters, water pumps, restroom dispensers, and backflow devices; may make minor electrical installations and adjust, repair, and maintain electrical equipment; perform other related work as required.

EMPLOYMENT STANDARDS

KNOWLEDGE AND ABILITIES

Knowledge of:

Methods, techniques, and procedures used in maintaining swimming pool equipment;
Basic methods, techniques, tools, materials, and equipment used in maintenance, repair, and construction work;
Rules, regulations, and operational procedures pertaining to the repair and maintenance of school buildings, swimming pools, and equipment;
Safe working methods and procedures.

Ability to:

Effectively and efficiently clean, sanitize, and maintain commercial type swimming pool facilities, surrounding areas, and related equipment;
Maintain proper chemistry of swimming pool water;
Operate a variety of power-driven equipment, testers, gauges, and small hand and power driven tools;
Maintain simple records and prepare reports;
Understand and carry out written and oral directions;
Meet schedules and timelines to accommodate aquatic activities;
Establish and maintain an effective working relationship with those contacted in the course of work;
Relate effectively with racially and ethnically diverse staff, students, and community.

EDUCATION AND EXPERIENCE

Education:

Equivalent to the completion of twelfth grade, supplemented by training or course work in the operation of commercial type swimming pools, facility maintenance, and plumbing.

Experience:

Two or more years of combined increasingly skilled experience in commercial swimming pool operations, facility maintenance, and plumbing.

REQUIRED LICENSES AND CERTIFICATES

Possession of a valid and appropriate California driver's license; have an acceptable driving record; qualify for insurability by the District's insurance carrier.

Must obtain and possess a Certified Pool Operator Certificate within the first 6 months of employment; certificate must be in accordance with National Swimming Pool Foundation requirements.

PHYSICAL REQUIREMENTS AND WORKING CONDITIONS

Heavy work involving lifting, carrying, pushing, and/or pulling of objects weighing up to 100 pounds with frequent lifting and/or carrying objects weighing up to 50 pounds. Physical dexterity in limbs and digits to operate hand and power-driven tools and equipment commonly used in one or more of the basic maintenance trades and swimming pool operation.

WORKING CONDITIONS

Duties may involve working off the ground using ladders, scaffolds, and mechanical lifts. Required to work with common pool chemicals and in outdoor inclement weather conditions.
